# 4. First-aid Measures

### 4.1 Description of First Aid Measures

**GENERAL NOTES:** Show this safety data sheet to the doctor in attendance.

AFTER INHALATION: Move to fresh air. Provide fresh air, rest and warmth. Call a physician immediately. Give oxygen or artificial respiration if needed.
