4. First-aid Measures

4.1 Description of First Aid Measures

GENERAL NOTES: Show this safety data sheet to the doctor in attendance.

AFTER INHALATION: Move to fresh air. Provide fresh air, rest and warmth. Call a physician immediately. Give oxygen or artificial respiration if needed. When risk of unconsciousness, place and transport the victim in secured recovery position. **AFTER SKIN CONTACT:** Use a mild soap if available. Wash off immediately with soap and plenty of water while removing all contaminated clothes and shoes. If skin irritation persists, call a physician. Do not use solvent or thinners to clean skin. **AFTER EYE CONTACT:** Rinse immediately with plenty of water, also under the eyelids, for at least 15 minutes. Remove contact lenses.
